- 4. Sign the form in Section 4; a digital signature is **not** acceptable.
- 5. Submit the completed form via one of the methods listed at the bottom of this form.

**NOTE:** You <u>must</u> be registered for courses before enrollment can be reported to the VA. In order to ensure that you receive the appropriate benefit, it is <u>your</u> responsibility to inform the School Certifying Official if you modify your enrollment <u>after</u> submitting this form. <u>You</u> are responsible for any debt assessed due to a change in your enrollment status.
