<u>4.1.00</u> Purpose

The purpose of this Policy is to establish the Marquette University Police Department's (MUPD) Designated Patrol Zone.

4.1.10 Policy

The Designated Patrol Zone of the Marquette University Police Department (MUPD) shall include all real property owned by Marquette University and adjacent areas located within the marked geographic area identified in Addendum A.

4.1.15 Scope

This policy applies to all MUPD employees.

4.1.25 Boundary Restrictions


- A. The following general geographical restrictions for MUPD patrols are assigned as follows:
 - South to Clybourn Street/Tory Hill (turns into Michigan east of the interchange) from 8th Street to 22nd Street, south to Michigan from 22nd Street to 24th Street.
 - **East** to James Lovell Street in the 500 block, 8th Street in the 600 block, James Lovell Street in the 700 block, 11th Street in the 800 block, 14th Street in the 900 and 1000 blocks.

- North to Wells Street from James Lovell to 11th Street, to Highland from 14th Street to 17th Street and from 20th Street to 23rd Street, to State Street from 17th Street to 20th Street.
- West to 22nd Street in the 500 block, 24th Street in the 600 and 700 blocks, 23rd Street in the 800 block, 20th Street in the 900 block, and 17th Street in the 1000 block.
- B. Additionally, the following areas outside of the general geographical restrictions are defined as within the Designated Patrol Zone for patrol and reporting purposes.
 - The 16th Street viaduct from Clybourn Street to the Valley Fields viaduct gate.
 - Clybourn Street from 22nd Street to 27th Street for the purposes of responding to the 2601 Service Garage.
 - Direct routes leading from campus to Valley Fields, and Canal Street adjacent to Valley Fields.
- C. Should Marquette University determine that it may be necessary or appropriate to expand or to contract the Designated Patrol Zone, it shall propose such change to the Wisconsin Department of Justice for review and approval and to the Chief of Police, Milwaukee Police Department, for review. The Designated Patrol Zone shall be changed on a date no less than thirty (30) days after the date on which the change was proposed.
- D. For reporting purposes:
 - 1. "Within MUPD Designated Patrol Zone" consists of the city street and both city sidewalks adjacent to each street (both sides of the street).
 - 2. Private Property past the far sidewalk is "outside the MUPD Patrol Zone" for reporting purposes.
- E. An officer may leave the Designated Patrol Zone only with the approval of the Shift Commander or when assigned by the Command Information Center.
- F. In addition, pursuant to section 175.42 of the Wisconsin State Statutes, a Marquette University police officer may, when in fresh pursuit, follow

Policy 4.1 Designated Patrol Zone Page 2 of 4 anywhere in the State of Wisconsin, within or without the Designated Patrol Zone, and arrest any person for violation of the laws of the State of Wisconsin.

- G. Any escorts going outside of the Designated Patrol Zone must have the approval of the Shift Commander unless assigned by the Command Information Center.
- H. Notwithstanding the foregoing, Marquette University will not in any manner attempt to discourage or dissuade any person from making a police report or requesting police service from other law enforcement agencies with jurisdiction within the Designated Patrol Zone. If any person specifically requests that a matter be handled by another law enforcement agency with jurisdiction within the Designated Patrol Zone, rather than by the MUPD, that request will be forwarded promptly to the other law enforcement agency.
