

### **Exciting News regarding the CPI 3.0!!!**

In 2022, APTA made the decision to invest in the psychometric review of the PT and PTA CPIs to align the content and scoring model to best practices in 2023. That work was completed in partnership with Human Resources Research Organization (HumRRO) in November 2022. APTA is currently working with its new technology vendor, Competency.AI, to have these tools available for use in an electronic, mobile friendly platform with a GO LIVE DATE: May 15, 2023. Watch for information from individual programs as to when their specific transition to the new system will occur.

Since the APTA made MANY changes to the CPI including: reducing the number of criteria from 18 to 12 for PT and 18 – 11 for PTA, ALL USERS will need to take updated training to access CPI 3.0.

Five courses specific to PT and PTA CPI 3.0 can be found in the APTA Learning Center. These courses are specific to a user role and are required before one can access CPI 3.0. These courses are free, and no registration is required.

The courses include a narrated video, approximately 20-28 minutes in length based on the course version. The videos allow participants to pause or rewind but does not allow them to fast forward. The assessment includes 16-21 questions depending on the course version. Participants must score a 100% on the assessment to receive their certificate of completion. The assessment can be taken as many times as needed to achieve the passing score.
